General Information

- *Plantskydd* Deer Repellent is effective in preventing deer browse on emerging plants, and lasts for months on dormant plants when used as directed.
- Works by emitting an odor—not unpleasant to applicators.
- **Do not apply directly onto edible parts of fruit, vegetables and other food crops.**
- Cannot be used as a pre-emergent and is not systemic in function.

Directions for TANK MIX

- *Plantskydd* is a wettable powder that requires strong agitation.
- Add a medium rate of defoamer to water **first**.
- Slowly pour *Plantskydd* powder concentrate into water while agitating vigorously. (see: *Dilution Rate* table below).
- If heavy rain is anticipated, add additional spreader sticker.
- Agitate solution thoroughly before spraying.

Directions for SMALLER APPLICATIONS

- Add 3 gallons of water to a 5 gallon bucket.
- Add a medium rate of defoamer to water.
- Using a drill with a paint mixer attachment, set to medium speed — pour *Plantskydd* powder concentrate down vortex while mixing.
- Strain mixture using paint strainer or other 50 US mesh strainer.

Note: *Plantskydd* Repellent has demonstrated excellent plant safety and tank mix compatibility. If in doubt, conduct a 'jar test' and spray small area.

- **Spray on dry plants. Rainfast in 24 hours.**
- **Deer and Elk** — spray all plants and leaves until wet but not dripping.
- **Buck Rub** — spray all around tree stem.
- **Rabbits & Voles** — spray lower leaves, including stem down to root collar.

Leaf Hardening (mid-summer)	21 - 31 days
Dormancy	90+ days
