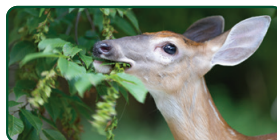

DIRECTIONS

For best results, treat plants before browse begins. Shake container well before each use. Pour into pump-style sprayer. Use mist setting. Flush after each use. Apply on dry plants, above freezing temperatures and allow solution to dry thoroughly for at least 24 hours before watering, or the onset of rain or snow. Rainfast in 24 hours. After spraying, petals /leaves darken temporarily. Test sample plants to determine sensitivity. Seal with jug cap. Use within 90 days after breaking seal.

How often do I need to treat my plants and trees?

- Spring/Summer: Dilute with 1 part water and reapply every 10-14 days during rapid growth, once a month thereafter.
- Fall/Winter: Reapply every 90 days and during a mid-winter thaw.

APPLICATION INFORMATION:

Safe for protecting flowers, shrubs, trees and landscapes when used as directed.

- **Deer / Elk / Moose**—spray mainly top of plant until wet, but not dripping.
- **Rabbits & Voles**—spray stem area, lower and underside of leaves.
- **Buckrub**—apply liberally on tree trunk and limbs.
- **Overwinter**—prior to freezing temperatures, apply liberally to shrubs, hedges and trees. Reapply during midwinter thaw.
- **Ornamentals**—spray mainly leaves of plants until wet—avoid blossoms.
- **Bulbs**—spray bulbs, allow to dry, and then plant.
- **Always treat new growth.**
